NO - The effect is neutral because –

Lap dancing and similar premises are currently licensed under the Licensing Act 2003. No special provisions are made for such premises under this act.

If the new powers are adopted the control measures are wider and include consideration of the appropriateness of the premises having regard to:

- The number of sex establishments in the area
- The character of the locality
- The use to which other buildings in the vicinity are put, and
- The layout, character or condition of the proposes premises

In the context of the above, it is considered that sexual entertainment venues would not generally be appropriate near or in locations/ or areas containing any of the following:

- Historic buildings or tourist attractions
- Schools, play areas, nurseries, children centres or similar premises
- Shopping complexes
- Residential areas
- Places of worship

If the powers are adopted the Licensing Authority can also apply prescribed standard conditions on grounds not covered by the Licensing Act 2003 e.g. location, hours, display of adverts, visibility of interior.

The Council will draw up a draft policy in relation to sexual entertainment venues. Although not a legal requirement, the policy will be subject to consultation and an equality impact assessment. There is the potential for representations to be made by community groups, etc.
