FORWARD

Welcome to our new Homelessness and Rough Sleeping Strategy, which sets out our strategic aims and plans for providing and improving services for homeless households in the district over the next five years. Although this is not our first homelessness strategy, it is the first to have a specific focus on rough sleeping and to consider the effectiveness of homelessness following the introduction of the Homelessness Reduction Act in 2018.

Hyndburn is a small district council located in East Lancashire in the North West of England and whilst homelessness is not a major problem compared to the larger more urban areas it is a complex situation, often going beyond the essential requirement to provide suitable, sustainable accommodation and involving addressing a number of personal support needs.

Reducing homelessness and rough sleeping is a key priority for the council. Finding sustainable and lasting solutions requires a holistic and joined up approach from organisations across the borough. Hyndburn has a track record of strong partnership working in tackling homelessness both within the Borough, across Pennine Lancashire and county wide.

This revised 'Prevention of Homelessness and Rough Sleeping Strategy' has been produced with the input and involvement of a wide range of people and organisations including customers,

Registered providers of social housing, voluntary sector organisations and public sector partners.

Thanks to all of you who contributed to developing this new strategy for the next five years and to everyone who delivers services and works with homeless households in Hyndburn every day.

INTRODUCTION AND CONTEXT

The Homelessness Act 2002 requires every local authority to carry out a review of homelessness every 5 years and publish a strategy based on the results of the review. This strategy is based on the findings of consultations with partners, stakeholders and service users, a desk top review of statistics and actions from the previous strategy and forms the evidence base for this strategy and action plan.

National Context

The following national policies guide and shape the delivery of local homelessness services:-

- Homelessness Reduction Act 2017 – came into force in April 2018. The Act has prompted new ways of working and preventing homelessness
- National Rough Sleeping Strategy / Action Plan 2018 – the Government is committed to halving rough sleeping by 2022 and ending it by 2027
- Making Every Contact Count – details '10 Local Challenges' set by the Government to improve local services to homeless households
- Welfare Reform Act 2012 – includes the introduction of Universal Credit

Local Context

Hyndburn's Corporate Strategy commits to 'delivering strong housing growth & improved housing choice'. In addition the Prevention of Homelessness and Rough Sleeping Strategy aligns with the following local and sub-regional strategies:-

- Lancashire Health & Wellbeing Strategy
- Pan Lancashire Domestic Abuse Strategy
- Pennine Lancashire Housing Strategy 2009-2029
- Hyndburn Community Safety Partnership Plan 2018-19


This strategy defines the strategic approach that Hyndburn Borough Council and its partners will take towards addressing and tackling homelessness in the borough over the next 5 years by finding lasting and effective solutions.

The 4 strategic aims for Hyndburn's strategy are as follows:-

- Prevention and Relief of homelessness
- Provision of temporary accommodation
- Working with landlords and suppliers of accommodation
- Tackle and reduce the levels of rough sleeping

The action plan details specific activity to meet these aims.

PREVENTING HOMELESSNESS ACHIEVEMENTS SINCE 2014



REVIEW PROCESS AND CONSULTATION

Throughout 2019 a full consultation on the current homelessness situation was carried out in Hyndburn. The following methods were used:-

- Homeless in Hyndburn Forum – presentations, workshops and discussions
- Desktop analysis of statistics (Hyndburn Borough Council and partners)
- Desktop review of literature, research and policies
- Housing Advice service user survey
- One to one consultation with stakeholders
- Hyndburn Health & Wellbeing Partnership discussion
- Hyndburn Community Safety Partnership discussion
- Private Landlord Workshop
- Regeneration & Housing Members Panel

There is a separate review document that gives an overview of the current homelessness situation in Hyndburn by looking at the main causes of homelessness and the current levels of homelessness of all client groups. Details are given of the

accommodation, support and prevention services in place for all clients groups.

REASONS FOR HOMELESSNESS IN HYNDBURN

The main reasons for homelessness and housing advice queries in Hyndburn, during the last 5 years (2014-2019) were:-

- Ending of private rented tenancy
- Family / friends no longer willing / able to accommodate
- Domestic abuse / non-violent relationship breakdown

This reflects the national picture.

The top support needs of households assessed by the Council during 2018/19 were:-

- History of mental health problems
- Physical ill health and disability
- Learning disability

Single people (of all ages) make up the majority of all approaches for assistance.

KEY FINDINGS OF THE CONSULTATION

Challenges – Hyndburn faces a number of significant challenges in delivering homeless prevention services.

- Cuts in funding and services provided by partners e.g. Lancashire Wellbeing Service, Welfare Rights
- Impact of welfare benefit changes
- Lack of suitable temporary accommodation in the Borough
- A lack of and long wait for support services
- Increase in the levels of rough sleeping
- Barriers to accessing social and private sector housing

Improvements / Changes identified

- More preventative work
- Better communication / partnership working
- More temporary accommodation
- Rough sleeper outreach services
- Tenancy support

GOVERNANCE, DELIVERY & MONITORING

The strategy action plan will be monitored and updated through the Homelessness Strategy Monitoring Group on a regular basis throughout the lifetime of this strategy with regular reporting to the Homeless in Hyndburn Forum. The action plan identifies who is responsible for the completion of specific tasks and timescales.
