Dear Michael,

Following Tuesday's Hearing I promised Mr Pratt that I would revert once today's Hearing in Preston, concerning the identification of Omega Atlantic's land as a suitable site for a large scale built waste management facility in Lancashire's Minerals & Waste Site Allocations DPD, had taken place. I can now update Mr Pratt as follows.

After a long debate it was agreed by the County that the removal of my client's land from that identified in map reference BWF8 would not undermine the plan or its soundness. As such, it was agreed by all parties that it would be removed. It follows that any reference to built waste management facilities should be removed from Policy A8 of Hyndburn's Core Strategy. Changes should also be made to the supporting text where relevant.

I hope the above is clear and I would be grateful if you could pass this email on the Inspector.
