Built in 1868 by John F Doyle, this striking Grade II listed building sits at the heart of Accrington town centre. Accrington is the gateway to the Pennines, Lake District, Ribble Valley and the Forest of Bowland; some of the most attractive areas and compelling landscapes the UK has to offer.

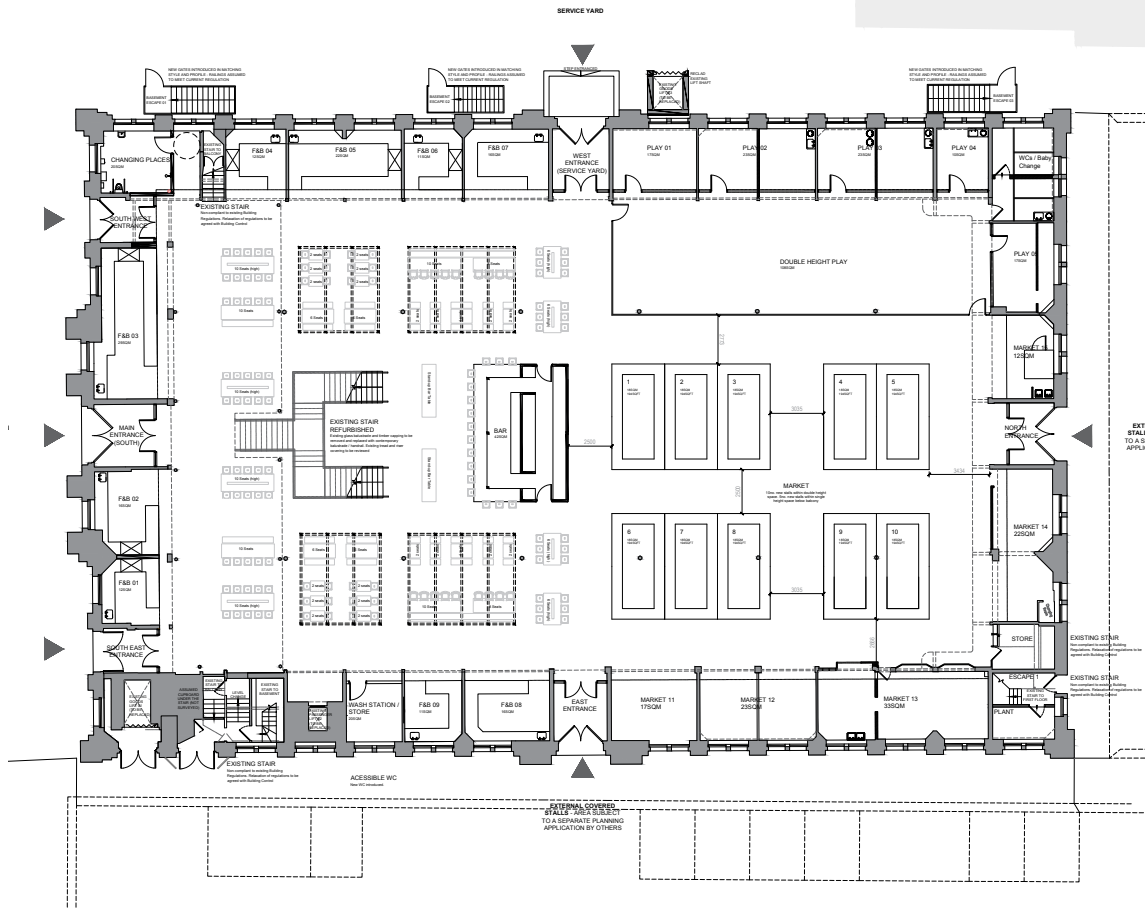

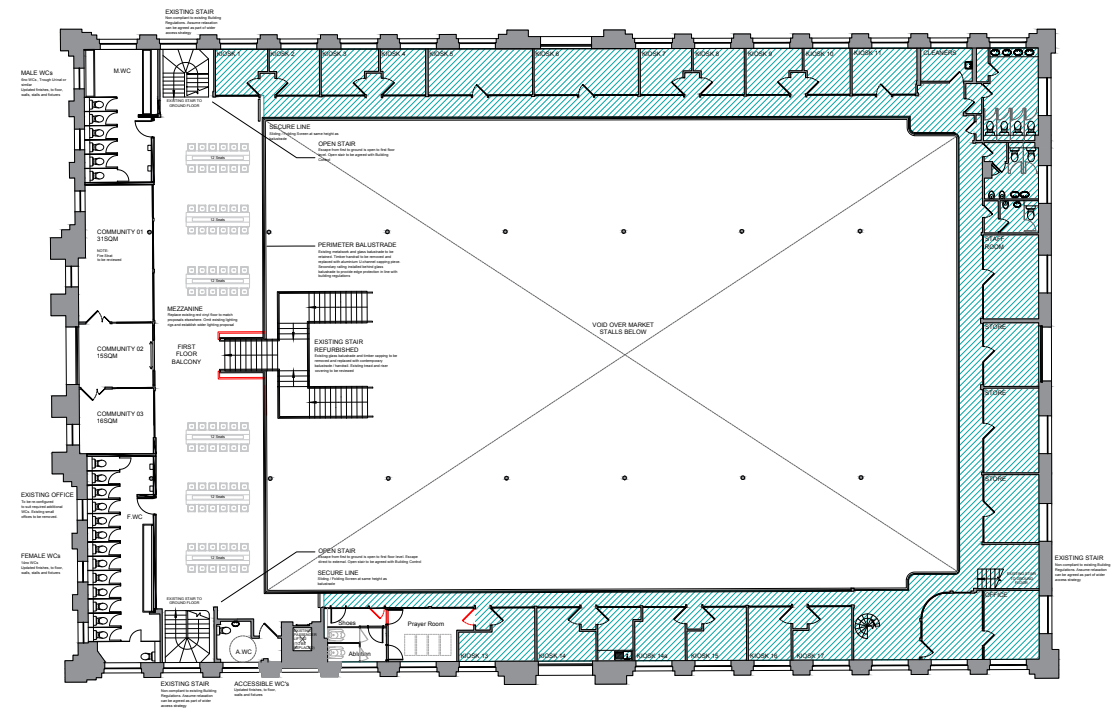

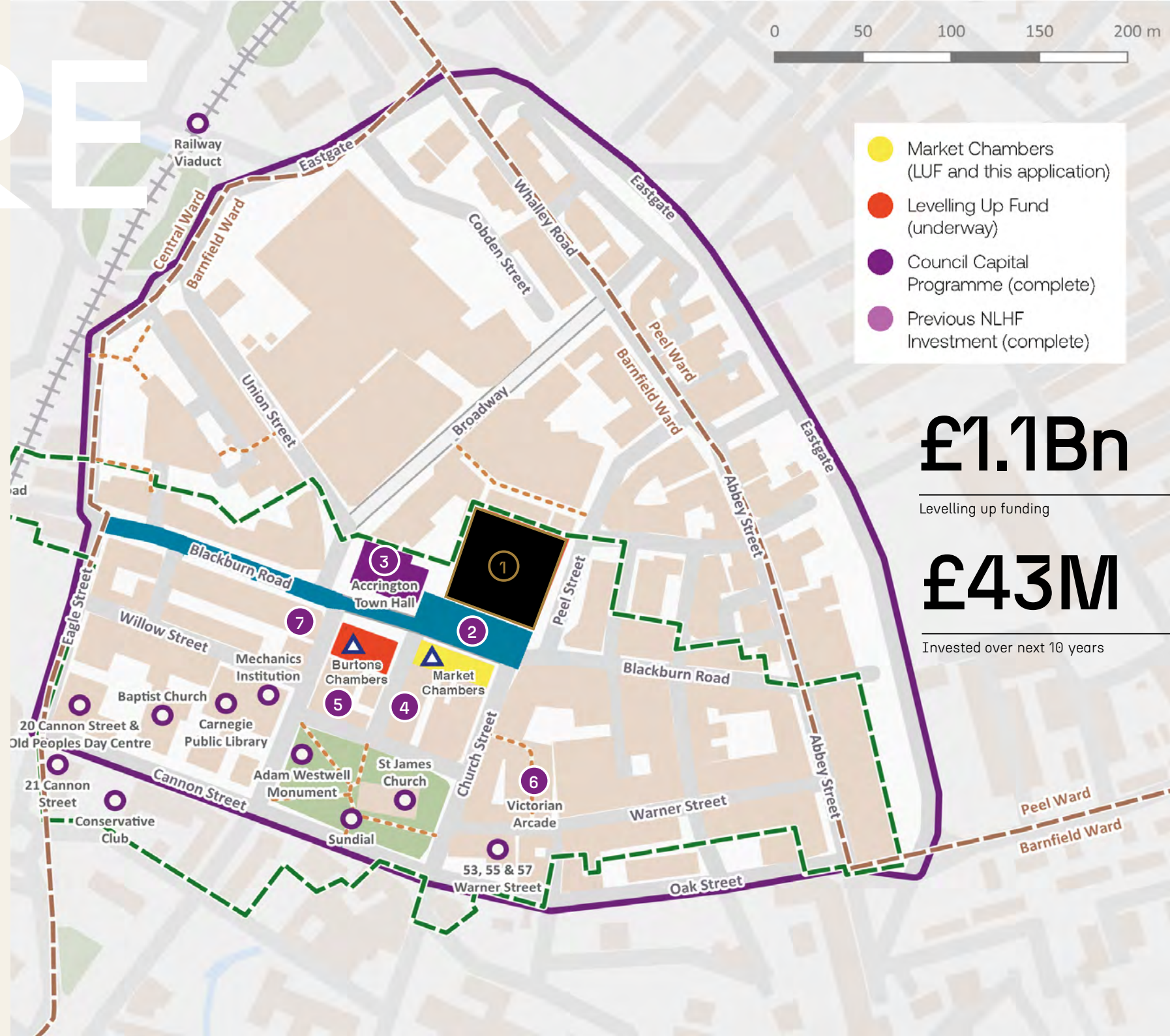

Accrington is one of only 55 towns benefitting from the latest £1.1 billion of levelling up funding. There will be £43m invested in the town over the next 10 years.

- The Market Hall, Accrington** – to be re-fitted and re-furnished as the new town centre anchor.
- Accrington Town Square** - Town Square and nearby architectural highlights will be transformed into the town's 'anchor'.
- Town Hall** - enhanced with façade improvements and restoration work.
- 43 Blackburn Road / 2-4 Church Street** - properties transformed into a heritage, culture, and arts space.
- Transformation of Burton Chambers** - ground floor to renovated as co-working and office space.
- Transformation of Victorian Arcade** – council are working with the owner to attract more independent businesses.
- Repurpose old Yorkshire Bank building** - to be repurposed back into use as a restaurant, café, community museum or a commercial office space.
